Example: How to Format Associated Content Articles

Introductory paragraph: Keep it short—limit it to 3-4 sentences, if possible. If you need to include more text, make another paragraph.

First section: Each section should include a bolded subheading, explaining what the section is about. Make the subheading short and simple.

Again, keep it short—no more than 4 sentences per paragraph.

Including a fact from another source? Clearly state the source of the fact, as indicated here.

Donec non ipsum sed augue condimentum hendrerit in vitae tortor. Sed a dolor metus, vel consequat arcu. Quisque sapien est, pretium in varius et, porta eget lacus. Donec eu lacus sit amet arcu egestas bibendum. Sed vehicula consequat fringilla.

Aliquam sapien lorem, luctus ac hendrerit sit amet, porttitor id nulla. Fusce tempus ullamcorper nulla sed dapibus. Vivamus et consectetur lectus. Nulla facilisi.

Suspendisse tortor nibh, suscipit sed aliquet eu, faucibus a erat. Etiam tortor ante, vulputate vel accumsan id, vestibulum sed velit. Donec leo orci, venenatis sed aliquam non, pretium semper lacus.

Integer Eget Dolor Metus

Cras turpis enim, malesuada eu cursus vel, dapibus et dolor. Sed ultrices justo ut nunc fermentum nec ullamcorper augue venenatis. Mauris fermentum nisl at dolor bibendum scelerisque.

Curabitur ut porttitor tortor ? According to the University of Michigan, justo non euismod 78%, massa velit pretium elit, eu hendrerit neque leo eget lectus.

consequat leo, eu rutrum arcu metus sollicitudin lorem. Vestibulum diam nunc, viverra ut feugiat in, lacinia eu magna. In vestibulum gravida justo, eget facilisis mauris fermentum nec. Integer sapien nunc, fringilla et iaculis ac, blandit at ipsum.

FYI: This is the conclusion. Every Associated Content article needs a conclusion (it's not required, but strongly recommended). Again, keep the paragraphs short, 3-4 sentences max per paragraph.

Integer Eget: Justo Non Euismod

Sed a dolor metus, vel consequat arcu. Quisque sapien est, pretium in varius et, porta eget lacus. Donec eu lacus sit amet arcu egestas bibendum. Sed vehicula consequat fringilla. Vivamus porttitor gravida quam eu accumsan.

If you attributed a source in the article, write "Sources:" after the conclusion and type the source as so:
